Job Title: Staff Industrial Hygienist

General Responsibilities:

Under general supervision from Management, the employee will have responsibility for conducting a variety of industrial hygiene, ergonomic and environmental tasks. Tasks can vary from day-to-day, but will include

- a) office-based workplace ergonomic assessments, developing corrective action plans and follow-up assessments estimated 65-70% of overall responsibilities;
- b) industrial hygiene evaluations including employee monitoring, chemical inventory and management, lab safety and indoor air quality studies estimated 20-25% of overall responsibilities;
- c) environmental management including air/water/solid waste permitting, hazardous materials business plan management, UST and storm water program management estimated 10-20% of overall responsibilities.

This position is based in Los Angeles (west side). Travel within California but outside of the greater Los Angeles area may be required.

Prerequisites:

- 1. Experience: Fundamental understanding of Industrial Hygiene, Environmental Compliance and Ergonomic principals. This can be met through a combination of hands-on field experience and college study. The ideal candidate will possess a minimum of a Bachelor's degree in the health sciences plus two years of related experience.
- 2. Office Ergonomics: The ideal candidate will have experience in conducting workplace evaluations specific to computer/workstation use. The candidate will be familiar with federal OSHA "e-tool for ergonomic computer workstations"; and other research, industry and governmental compliance programs and resources.
- 3. Environmental Regulation familiarity: The ideal candidate will have a broad understanding of local, state and federal regulations including: 40 CFR, 22 CCR, 17 CCR, 8 CCR, SCAQMD.
- 4. Oral Communication skills: The candidate must be able to demonstrate effective interpersonal skills as this position requires significant personal interaction in a variety of settings.
- 5. Written Communication skills: The candidate must be able to demonstrate the ability to prepare thorough, yet concise written technical reports using MS Office;
- 6. Computer Literacy: The candidate must be able to navigate through MS Office applications, database programs, graphics (Autocad LT)

- 7. Certification(s): Although not required, the ideal candidate will be on-track to pursue professional certification in the following disciplines: Board Certification in Industrial Hygiene (w/in 5 years), Board Certification in Safety Engineering (w/in 3 years), State Certification in Asbestos Consulting (w/in 3 years), State certification in Lead Consulting (w/in 3 years).
- 8. Personal transportation is required along with state-required insurance.

Compensation
