- Treasurer: Daniel Blake submitted the ARF Treasurer's Report for November 1919. The total of Account Balances as of November 11: \$145,004.63. This is an increase from the previous month of \$1,673.83. Total income: \$2,156.31. Total expenses: \$482.48 (including a one-time expense of \$206 for PO Box Rent). Overall Net Income: \$1,673.83.
- 2. Membership Chair. Diane Schwartz reported that presently ARF has 205 members, an increase of 5 since October. Early in November Diane sent out 36 reminder notices to 2018-2019 ARF members who have not yet renewed. She expects that more than half of them will renew. Larry Caretto is adding the members' renewal/application information to the ARF database. When that is complete he will update the arfmembers-I mailing list.
