- Call to Order: President Bourgeois called the meeting to order at 11:15
 a.m.

 - a. President Bourgeois reported that somehow last week the telephone and internet systems of the ERFSA / ARF Office ("Retiree Center") on campus were disconnected. With some difficulty she was able to get these systems reconnected. In the

process she discovered that campus directory does not have an accurate telephone number for the Retiree Center. Eugene Turner will see that a correct phone number is available on the ARF Website.

- b. By now everyone should have a ballot for the upcoming CalPERS election. Votes must be submitted by September 30.

 - a. CalPERS Open Enrollment. Catherine Jeppson noted that to change coverage a CalPERS member must present valid evidence (e.g., a marriage license) of a dependent's relationship.
 - b. CalPERS Election. Catherine Jeppson announced that she will be available to discuss the election at lunch.

- 1. Treasurer: Daniel Blake
 - a. ARF Treasurer's 2019 Annual Report. By comparing 2017-18 and 2018-19, the Report shows that Total Income (\$27,893.36) increased by \$1,569.07; Total Expenses (\$18,218.40) increased by \$1,364.22; and Total Account Balances (\$132,480.23) increased by \$9,674.96.
 - b. ARF Treasurer's Report: September 2019. During this period expenses exceeded income. Total Income: \$3,230.25. Total Expenses: \$10,704.73). Overall Net Income: -\$7474.48. The

negative excess was due primarily to expenses relating to the Memorial Awards (\$8,000), the Memorial Awards Brunch (\$1,034.51), and the Annual Picnic (\$1,084.83). Substantial income from membership dues has not yet been received.

2. Membership Chair: Diane Schwartz

- a. Membership remains stable. Currently there are 249 members including 18 new or returning members.
- b. Vote on non-CSUN membership application. Joel Weiner, Emeritus Professor of the University of Hawaii, and his wife, Gail, have applied for membership in ARF. MSP to approve the Weiners' membership application and welcome them to the Association.
