REPORTS

1. Treasurer. Cathy Jeppson

2. Program Chair. Patrizia Miller

Pat remarked that there were not many changes from, or additions to, the 2024 – 2025 ARF Program Calendar emailed over recent weeks. She reiterated that today's speaker would be Art Shulman, and that on January 18 there will be a "Stomp" performance at 3:00 p.m. at the Soraya, with perhaps a reception.
