#### **Tax Fellowship Program**

This academic year we launched the Tax Fellowship Program, which is offered by the M.S. in Taxation Program and the Department of Accounting & Information Systems at Cal State Northridge. This is an innovative collaboration with a select number of accounting firms in the Los Angeles area with the goal of identifying and cultivating the next generation of leading tax practitioners. The participating firms are: Ernst & Young, LLP, RBZ, LLP, Rothstein Kass, LLP, Moss Adams, LLP, and Singer Lewak.

The goals of the Tax Fellowship Program are:

- Provide mentorship opportunities in the field of tax to high achieving undergraduate accounting students beginning in their junior year in College;
- Provide short term work experience in the field of tax to high achieving undergraduate accounting students;
- Provide monetary support to high achieving undergraduate accounting students with an interest in tax;
- Provide advanced level tax education to high achieving undergraduate accounting students upon graduation.

The benefits to the selected Fellows are:

- Develop a mentorship relationship with an experienced tax practitioner beginning in the junior year in College;
- Obtain valuable work experience in the field of taxation while completing the undergraduate degree in accounting;
- Obtain a stipend from the sponsoring firm while completing the undergraduate degree;
- Gain automatic admission into the graduate degree in taxation at Cal State Northridge upon graduation with a B.S. degree in accounting:
- Obtain tuition reimbursement for the graduate degree in taxation from the Sponsoring Firm.

• Enhance the programs' scholarship offerings.


Finally, the benefits to the sponsoring firms are:

Faculty Profile Jeffrey M. Tolin



Teaching corporate tax in our M.S. in Tax program, Professor Tolin is also a Tax Principal and Senior Tax Advisor for the entertainment industry at Ernst & Young LLP. He was formerly the national Entertainment Tax director at Ernst & Young, LLP. His wealth of experience and prominence in the field has clearly made an impact in the classroom. At the conclusion of the corporate tax course last winter, students raved about Tolin's teaching skills.

One student wrote in the end of the semester faculty evaluation: "The instructor is very knowledgeable. He knew the material like the back of his hand. His transactional approach to corporations helped to bring the code to life."

Following his first time teaching at Cal State Northridge last fall, Professor Toliln stated: "I'm delighted to participate in the MS Tax program. The opportunity to work with CSUN's highly engaged students and supportive staff has been one of the highlights of my career." Professor Tolin has extensive experience serving companies engaged in motion picture production, distribution and exhibition, television broadcasting and cable and video operations. He also has extensive international and domestic corporate tax experience including mergers, acquisitions and reorganizations. He received his B.S. from New York University in Accounting, his J.D. from Brooklyn Law School and his LL.M. in Tax from New York University. He is a member of the Motion Picture and Television Tax Institute, and a Member of the New York State Bar Association.

Professor Tolin has published several books and articles and is a frequent lecturer. One of his most recent publications is unique in that it is perhaps the first tax comic book ever published. Together with Michael H. Salama, the Vice President for Tax Administration and Senior Tax Counsel with the Walt Disney Company, Professor Tolin authored GET SMART: ABOUT SPECIAL MANUFACTURING DEDUCTIONS. This graphic novel is a parody of the classic television show GET SMART. It integrates, says Tolin, humor with a substantive tax overview of Internal Revenue Code section 199, also known as the domestic production deduction for the film and television industries. Student Profile Leslie Sobel B.S. '83



I knew when I read about the cohort method that this was the Masters of Science in Taxation program I was looking for. As an undergraduate at Cal. State University Northridge, I served as a student body senator and sorority officer. I strongly believe it is our obligation to give as much to our community as we receive and have been a Boy Scout leader for ten years. I have forged new contacts in the MST program and consider the diversity here to be one of the programs greatest strengths. The program and my circle of contacts now includes CPA's and EA's in, trust and estate, big four, sole practitioners, business management, government, and industry specialists.

The MST program has changed my life in many wonderful ways. I never dreamed it would be this hard or rewarding. We are pushed to find the limits of what we are capable of achieving. Whether we are challenged to understand a new area of tax law or facing a personal challenge such as defending our tax research conclusions in front of the class, I found I was capable of so much more than I knew. It is difficult and overwhelming to work full time, raise a family and complete a masters program too. I would not make it without my husband who gets up to make my breakfast while I study, and my teenage sons, who taught me

how to animate my power point slides.

I took a circuitous path to being a Tax Professional and now I find this program has brought together all my experience so that I apply all I learn to my profession. I graduated Cum Laude with a B.S. in management and a minor in economics into an economy where factories were closing and managers were laid off. With CSUN Professor Richard Tontz' assistance, I found my first position preparing statistical analysis for litigation at Texaco. I returned to school at night to complete the accounting classes I needed to sit for the exam and earned my CPA license eight years after graduation. I went from senior accountant at Laventhol & Horwath, to industry, and back into public accounting with a two person CPA firm. Two years ago I joined Hinton, Kreditor & Gronroos, LLP a growing Pasadena firm which strongly supports the staff in their professional and charitable work and the partners urged me to pursue my masters. My client base is primarily mid-sized closely held business and I bring my knowledge of tax law and accounting to help them grow and flourish. I enjoy working closely with the owners to maintain the business through generations and adapt to the changing world. As accountants we are able to assist the businesses that keep our community working and strong. I consider it a privilege to be able to serve my community as a trusted bridge between our accounting community and the world.

Alumni Profile John Balian B.S. '89, M.S. '96



Even before obtaining his accounting undergraduate degree from Cal State Northridge in the late 1980s, John Balian began his tax career in 1986 when he was hired by the IRS as a Revenue Agent. In his capacity as a Revenue Agent, John audited a wide variety of closely-held corporations, sole proprietorships, highly compensated individuals and trusts. During his tenure with the IRS, John conducted forensic examinations of businesses in industries such as manufacturing, insurance, oil and gas distribution, law, accounting, medicine, real estate and entertainment. The focus of the audits was typically a search for unreported or diverted income and overstated or fictitious deductions. John's formal training at the IRS included extensive training in substantive tax law, internal IRS procedures and audit techniques.

Capitalizing on his accounting background and professional work experience with the IRS, John obtained his law degree from Southwestern University School of Law and his masters in taxation from Cal State University, Northridge. From 1994 to the present, John has practiced with the firm of Burgh, Balian & Bergstein, LLP in Studio City, California as the law firm's managing partner. During the past 14 years, John's tax and legal work has focused on estate and wealth preservation planning, income tax and capital gains deferral planning; and IRS Audit & Appeals representation. John is a Certified Specialist in Taxation Law, certified by the Board of

Legal Specialization of the California State Bar. He is the past chair of the West Valley CPA group of the California Society of CPAs' Los Angeles Chapter.

In 2008, John came back to his alma mater to join its faculty where he teaches the Culminating Experience in the graduate tax program and a Federal Tax Procedure course in the undergraduate accounting program. As part of these courses, John supervises the student-clinicians as part of the Bookstein Tax Clinic in their representation of low income taxpayers facing a dispute with the IRS.



## **Inaugural M.S. in Taxation Cohort**

Last October, we welcomed 30 highly accomplished tax professionals to our inaugural cohort of the M.S. in Tax program. The Master of Science in Taxation is offered by the College of Business and Economics in collaboration with The Tseng College. The degree, conferred by the College of Business and Economics, was created to meet the needs of those employed in the field of taxation who may require an advanced degree to achieve their career goals and to excel in their profession. The program prepares students to be professional tax advisers and consultants, as well as leading practitioners in both the private and public sectors.

Unlike other programs offered in our region, the M.S. in Tax program is offered in a cohort format whereby each fall a group of approximately 30 mid-career tax professionals participate in this evening and weekend graduate program. Over a period of 18 months, each member of the cohort is guaranteed enrollment in every class. Classes are presented one at a time in an accelerated mode and the schedule is set for the entire program at the outset. Courses are taught primarily by leading practitioners in the field.

Given our small class size, admission to this program is highly selective. For our recent class, the Admission Committee had nearly 90 applications for a targeted class size of about only 30. The typical admitted applicants were primarily CPAs who had on average 3.3 grade point average in their undergraduate studies, and five years of professional tax experience. About sixty percent of our entering students for the first cohort came from tax practice in public accounting, but almost twenty percent came from private industry, and another twenty percent were from government or operated their own practice.

The student body of the first cohort was highly diverse with half of the entering class being immigrants, who on average have been to the United States for almost 15 years. Almost forty percent of the entering students were female. The average age of students in our first cohort was 36. Most students came back to our program after an extended break from school. The typical student had finished his or her undergraduate degree over 9 years earlier. Those who applied and were admitted to our program regarded Cal State Northridge by in large as their first choice as displayed by an acceptance yield rate of 94%.

## **Tax Clinic Update**

The Bookstein Tax Clinic, launched in 2008, provides free federal tax controversy resolution services to low-income taxpayers residing throughout the Los Angeles area. Under the supervision of an experienced tax professional over 50 undergraduate and graduate students have participated as clinicians serving over 85 low income taxpayers facing a controversy with the IRS.

The Bookstein Tax Clinic also provides tax education to taxpayers not proficient in the English language by participating in numerous community outreach programs. Over the past six months, students facilitated over a dozen seminars and workshops to self-employed taxpayers throughout the Los Angeles area primarily on federal payroll tax issues. As part of the community service, students have authored several short articles on variety of tax issues affecting low income taxpayers. Some articles have been published in local newspapers, including Spanish language newspapers.

Undergraduate and graduate accounting students are provided the opportunity to handle various aspects of controversies with the Internal Revenue Service, including interviewing clients, preparing cases for appeals conferences and appearing at the conferences themselves, preparing offers-in-compromise, and negotiating settlements with the Internal Revenue Service. The Bookstein Tax Clinic provides students high quality training that is transferable to both large firm and solo practices. Students are required to attend classes and work independently and in teams on their cases with diligence, excellence and efficiency. Earlier this year, the Bookstein Tax Clinic received a \$47,000 grant from the U.S. Treasury Department to support the clinic's activities and service in the community. Most recently, Citi offered its support of our educational outreach services by providing a generous grant.

Our annual clinician recognition reception is scheduled to take place on Saturday, December 13, 2008.
