ELIGIBILITY:

Applicants must be one of the following:

- High school senior who wishes to pursue a career in teaching at California State University, Northridge through either the Integrated Teacher Education Program (ITEP), Freshman Option to become an elementary or special education teacher, or the Four-Year Integrated (FYI) Program to become a secondary teacher in English or Mathematics.
- Community college student who wishes to pursue a career in teaching at CSUN through either the Integrated Teacher Education Program, (ITEP), Junior Option to become an elementary or special education teacher, or the Junior-Year Integrated (JYI) program or become a secondary teacher in English or mathematics.
- CSUN sophomore who wishes to pursue a career in teaching thorough either the Integrated Teacher Education Program (ITEP), Junior Option to become an elementary or special education teacher, or the Junior-Year Integrated (JYI) Program to become a secondary teacher in English or mathematics.

AND

- Have a minimum grade point average (GPA) of 3.0
- Reside in either Los Angeles County or Ventura County.
- Have financial need as determined by Free Application for Federal Student Aid (FAFSA)
- Be a U.S. Citizen

Directions for Applying:

- Submit the Application for the Wells Fargo Teacher Education Scholarship to the Dean's Office in the Michael D. Eisner College of Education (ED3121) at CSUN no later than October 11, 2013, including the following:
 - Completed application form
 - Copies of transcripts from high school if you are a high school senior or from all colleges attended if you are a community college student or a CSUN sophomore.
 - Two letters of recommendation on official letterhead. Select persons who know you well enough to be able to evaluate your commitment and potential success in the field of education. At least one letter should be from a faculty member. No letters from family members will be accepted. Submit letters of recommendation with your application in a sealed envelope.
 - Typed personal essay (approximately 250 words) in which you describe a challenge, triumph, personal relationship or other life experience that has impacted your decision to become a professional educator.

SELECTION PROCEDURES:

- A Selection Committee will review all applications
- Oral interviews may be requested from qualified candidates after initial screening by the Selection Committee.
- Funds will be awarded in January 2014.
