Course Description:

Prerequisites: FIN 352; Grade of "C" or higher in FIN 303; Upper Division Writing Proficiency Exam (UDWPE) score of 8 or higher. BUS 302/L are prerequisites for Business majors. Portfolio management and performance evaluation and topics related to pension and other institutional fund management. It includes applications to portfolio benchmarking as well as discussions of alternative investment approaches and products.

Textbook and Calculator:

There is no textbook for the course but it is expected that each student will have access to the portfolio management part of a basic investments textbook. One option is the investments supplement to Welch's financial management text, which is available online for no cost. It is expected that all students can download information from the internet (including PDF files) and can use Excel for basic financial and mathematical calculations. Students will also need a financial calculator. There is a webpage (http://www.csun.edu/~jpd45767/452/fin 452.html) which serves as a guide to the class. You should bookmark it.

Grading:

The course grade is based on two exams, a midterm (40%) and a final (60%). +/- grading will be used. There are no early or makeup exams. You may not enter the classroom 30 minutes after the start of an exam. Each student will be required to make five presentations on ongoing events in financial markets which will serve as the foundation for class discussion.

This class will concentrate on the portfolio management parts of the Level 1 and Level 2 CFA exams.
