## Appendix M

## Early Completion Option Amendment to CSUN's Single Subject University Intern Program

As per the Commission on Teacher Credentialing, this option is available to Interns who pass the National Evaluation Series Assessment of Professional Knowledge for Single Subject Candidates (Test Code 052).

ECO candidates will advance to the final fieldwork course(s) and associated seminar(s). There are two ECO pathways: the Two-Semester (11 units) or One-Semester (7 units) ECO, as compared to the standard SSUIP of 4 semesters and 36-41 units.

The ECO must be completed in a single academic year that ends in May/June.

- Interns who begin the ECO in a fall semester may choose the One- or Two-Semester Option and must complete the program by the end of the spring of the same academic year.
- Interns who begin the ECO in a spring semester must choose the One-Semester Option to complete the program in the same academic year.

## **Two-Semester ECO**

- In Semester 1 (fall only), ECO Interns enroll in the course called *Supervised Field Experience for the Single Subject Credential*, consisting of supervised fieldwork, SED 554 (3 units) and an associated seminar, 554S (1 unit). Passage of SED 554/S is required to continue in the ECO and on to SED 555/S. The ECO Intern will not be required to meet the normal co-requisite course requirements for SED 554/S (SED 511, EPC 420, and SED 525xx).
- If the ECO Intern passes SED 554/S in the fall, then in Semester 2 (spring only), ECO Interns enroll in the course called *Supervised Practicum for the Single Subject Credential*, SED 555 (5 units) and the associated seminar, *Practicum Seminar for the Single Subject Credential*, SED 555S (2 units). The SED 555S seminar supports Interns in preparing the edTPA, which must be passed on the first attempt and prior to the end of this second semester.
- ECO Interns must also pass the course SED 514 *Computers in the Instructional Program* by the end of this academic year.
- Two-Semester ECO Interns who do not pass SED 554/S or SED 555/S during the ECO year will no longer be allowed to continue in the ECO. The Intern must then complete all remaining credential coursework and other requirements of the regular Intern program, including enrolling in the appropriate fieldwork course each semester.

## **One-Semester ECO**

- ECO Interns enroll in the course called Supervised Practicum for the Single Subject Credential, SED 555 (5 units) and the associated seminar, Practicum Seminar for the Single Subject Credential, SED 555S (2 units). The SED 555S seminar supports Interns in preparing the edTPA, which must be passed on the first attempt and prior to the end of this single semester.
- ECO Interns must also take and pass the course SED 514 *Computers in the Instructional Program* by the end of this semester.
- The Intern must then complete all remaining credential coursework and other requirements of the regular Intern program, including enrolling in the appropriate fieldwork course each semester.
