To: Candidates Admitted to the Ryan Multiple Subject and Single Subject Credential Programs
Subject: Completion Date of Ryan Teacher Preparation Programs

In 2001, the California Commission on Teacher Credentialing adopted new SB 2042 Standards for Multiple and Single Subject Teacher Preparation Programs. The Commission also adopted a two-year implementation plan for the transition of all approved Ryan programs to the new SB 2042 programs. This implementation plan would also allow candidates in the Ryan programs to finish their course work.

Candidates admitted to the Multiple Subject and Single Subject Credential Programs for Spring 2002 or earlier were admitted to Ryan Credential Programs. Also, candidates admitted to the Multiple Subject and Single Subject Credential Programs with BCLAD Emphasis for Spring 2004 or earlier were admitted to Ryan Credential Programs. These individuals must complete a Ryan teacher preparation program by 12/31/05. Candidates who finish their Ryan teacher preparation program by 12/31/05 have a choice for earning the professional clear credential by completion of either an approved Fifth Year Program or an approved induction program.

Candidates not finishing their Ryan teacher preparation program by 12/31/05 could transfer to an approved Preliminary SB 2042 teacher preparation program (see list of substitutions). An approved induction program would then need to be completed to obtain the SB 2042 professional clear credential.

In order to either assist you in the completion of the Ryan teacher preparation program by 12/31/05 or to seek an appeal with the Commission on Teacher Credentialing to extend the program deadline date, we need to know your status in the program. Please complete the bottom portion of this form and mail it back to the Credential Office in the enclosed envelope.
