COURSE DESCRIPTION:

Introduction to safe travel by kayak or canoe on lakes, rivers, and oceans. Includes equipment, navigation and techniques for flatwater boating and emergency self-rescue. Emphasis will be on the safety, environmental awareness, and skill development. Arranged fieldtrips are required.

COURSE OBJECTIVES:

- 1. Have a greater understanding of and appreciation for the natural environment and be able to incorporate minimum impact techniques in their travel
- 2. Show an increased ability to evaluate conditions and navigate their craft using safe water travel techniques
- 3. Synthesize information related to human physiology and external weather conditions and demonstrate proper emergency response to acute hypothermia
- 4. Apply a variety of paddle techniques for safe navigation of open canoes in both optimal and unexpected weather conditions
- 5. Apply a variety of paddle techniques for safe navigation of closed and open deck kayaks in ocean and flatwater conditions
- 6. Evaluate conditions related to group dynamics and develop a level of self-confidence and self-awareness in conjunction with understanding of the needs of others in the group

COURSE STUDENT LEARNING OUTCOMES:

At the conclusion of the course, students should be able to:

- 1. Identify the types and parts of equipment used in the course, including paddles, kayaks, canoes, and stand-up paddleboards.
- 2. Demonstrate the skills essential for a safe flatwater boating experience, including how to plan and prepare for trips (including weather & tide charts), how to fit a PFD, various paddle strokes, various paddling signals, competent self-rescue and participant rescue, and group management techniques.
- 3. Understand and articulate risks inherent to flatwater boating, including external weather conditions, and demonstrate the proper emergency response to acute hypothermia.
- 1. Learn and incorporate "Leave no Trace" principles in their travel.
- 2. Discover skills learned in the course that can be transferrable to other areas of life.
