## Selective Service Registration

The current federal law requires all males, between the ages of 18 and 25, to register with the Selective Service System. Your status with the Selective Service is checked prior to determining financial aid eligibility. If registration with the Selective Service cannot be confirmed, you must submit proof of registration or, if exempt from registering, you must submit documentation of your exempt status.

**To register on line, confirm your registration, or request a Status letter, visit the Selective Service System website at: [www.sss.gov](http://www.sss.gov).**

If you are a male student and fall within one of the following categories, you must submit proof of your status to the Financial Aid & Scholarship Department. Please submit photocopies of your documents, do not submit originals.

**I have registered with the Selective Service.** Attached is a photocopy of my Selective Service registration card, or print out from the Selective Service website.

**I am a Veteran** - Attach a copy of DD Form 214 indicating "honorable" discharge status or a copy of a military ID card.

**I entered the U.S. after the age of 26 years old and have not registered for Selective Service.**

Acceptable proof includes:

- A date of entry stamp on your passport
- Form I-94 with date of entry stamp on it, or
- A letter from the U.S. Citizenship and Immigration Services (USCIS) indicating the date you entered the U.S. or
- If you entered the U.S. without legal documentation after your 26<sup>th</sup> birthday, you must provide proof that you were not living in the U.S. from ages 18 through 25 (A Resident Alien Card or Green Card is not a valid proof of entry).

**I am over 26 years old and have not registered for Selective Service.**

You must attach: - A status information letter obtained from [www.sss.gov](http://www.sss.gov) **AND**  
- A written statement explaining your failure to register for Selective Service.

**I entered the U.S. on a valid nonimmigrant VISA and remained under the same status until my 26<sup>th</sup> birthday.** You must attach: - Documentation that indicates that you were admitted on an F-1 visa and attended school full-time as required. Acceptable documentation includes a copy of Form I-20 or a letter from the school you attended indicating full-time attendance as a nonimmigrant alien. The same applies for all nonimmigrant statuses.

**I have not registered with the Selective Service because I am exempt for the following reasons:**
