Earned Ph.D. in Construction Management, or Construction Engineering, or Civil Engineering with emphasis in Construction Management from an accredited institution. Candidates must have completed the Ph.D. degree by date of appointment (August 20, 2019). Candidates with Registration as a licensed Professional Engineer (P.E.), Certified Construction Manager (CCM) or Project Management Professional (PMP) are desirable. Teaching experience preferred. Industry experience preferred.
