## Classroom Conduct Professor Expectations

**SYLLABUS:** an agreement that outlines/summarizes topics covered in a course along with important dates, and instructors policies. It includes academic and behavioral expectations, resources, and course material

**ASSIGNMENTS:** Students are responsible for all assignments whether given in class or outside of class

**ONLINE INTERFACES**: CANVAS, ZOOM (be present, be live)

## Classroom Conduct Respecting the Classroom Environment

#### **DEVICES**

Know the rules on: Cell Phones, Laptops, Tablets, etc.

#### **PUNCTUALITY**

- Attend every class (sometimes grades depends on it!)
- Arriving late is disruptive

#### **PAY ATTENTION IN CLASS**

- Eating
- Sleeping
- Disruptive side Conversations
- Sit near the front
- Focus and take notes
- If you don't understand ASK
- Get involved in class discussions
- Be aware of deadlines
- Utilize office hours
- STUDY
- Be attentive to your CSUN email

#### **CSU Student Conduct Code**

"Students are expected to be good citizens and to engage in responsible behaviors that reflect well upon their university, to be civil to one another and to others in the community, and contribute positively to student and university life."

- Examples of prohibited conduct include academic dishonesty (ex: plagiarism), conduct that threatens or endangers, threats, harassment, hazing, use of illegal drugs, illegal use of alcohol and misuse of computer facilities or resources.
- Violations can result in admonishment, probation, suspension, or expulsion.
- Criminal laws are enforced on campus by CSUN Department of Police Service.

# Student Records & Privacy Act

#### **Student Records**

The Family Educational Rights and Privacy Act (FERPA) is the primary law governing student records. Once enrolled at a university, the rights under FERPA pass from the parent to the student.

#### **Those Rights Include:**

- The right to consent to the disclosure of records to a third party, including parents
- The right to prohibit the release of "directory information"
- A right of access to student records
- The right to challenge the contents of student records

#### Parent Access to Student Records

Generally speaking, parents should not expect direct access to student records (including student grades). A student may share with parents any record in the student's possession. Students may grant permission for parents to gain access to their records by providing a written statement providing:

The name of the specific record to be disclosed

The purpose of the disclosure

The name of the person to whom the record is to be released

## Student Safety Resources, Education and Prevention

### **Equity & Diversity**

### **Equity & Diversity**

Applies to: Students, Faculty/Staff/ Third Parties (known and unknown)

Prohibits Discrimination, Harassment and Retaliation

• Title IX is a special category of Sex Discrimination

Protected Status: Age, Disability, Gender/Sex, Genetic Information, Gender Identity, Gender Expression, Marital Status, Medical Condition, Nationality, Race/Ethnicity, Religion or Religious Creed, Sexual Orientation, Veteran/Military Status

Duty to Report & Exceptions (physicians, therapists, SA/DV, etc.)

Hearings vs. Informal Resolutions

#### Sexual Assault Prevention & Education

#### **College campuses are adjusting to many new laws:**

Violence Against Women Act - Campus Sexual Violence Act, and the Affirmative Consent Law.

#### **Prohibited behavior:**

Sexual misconduct, sexual harassment, sexual assault, sexual exploitation, prohibited consensual relationships, domestic violence, dating violence, and stalking.

#### At CSUN, student safety is our primary concern. The University:

- Strictly prohibits sex discrimination, including sexual harassment and sexual violence (sh/sv);
- Responds promptly when we know or have reason to know of incidents of sexual harassment and sexual violence;
- Communicates to students their rights and options, including the right to file a university complaint as well as a criminal complaint;

#### **Affirmative Consent**

\*\*\* ENGAGING IN SEXUAL ACTIVITY WITH ANOTHER MEMBER OF THE COMMUNITY MUST INVOLVE AFFIRMATIVE CONSENT \*\*\*

- Everything you think of as "sexual activity" including "touching intimate body parts."
- Consent must be INFORMED, AFFIRMATIVE, CONSCIOUS, VOLUNTARY and MUTUAL
  - Silence ≠ consent
  - Existence of prior relationship or prior consent ≠ <u>current</u> consent
  - Requests for condom/birth control ≠ consent
  - Incapacitation ≠ consent
  - Consent can be revoked and must be ongoing

### **Equity & Diversity: FAQs**

- What if I can't prove it?
- Can I stay anonymous?
- What if the other party does something to get back at me for reporting?
- My professor said something during class that was offensive, what can be done about it?
- Can your office give me a restraining order?
- When should I report?
- What do I do if something isn't quite discrimination/harassment/retaliation?

#### Sexual Assault Prevention & Education

- Communicates to students what the definitions of sh/sv, dating violence, domestic violence, stalking and affirmative consent;
- Provides prevention and awareness programs including mandatory "Not Anymore" Title IX Training.
- Provides on and off campus resources, both confidential and not; and,
- Has a Title IX Coordinator and an office on campus that receives all issues relating to sh/sv.

#### Zero Tolerance for Hazing

<del>)</del>

<u>Hazing</u> is any method of initiation or pre-initiation into a student organization or student body, whether or not the organization or body is officially recognized by an educational institution, which is likely to cause serious bodily injury to any former, current, or prospective student ... and in addition, any act likely to cause physical harm, personal degradation or disgrace resulting in physical or mental harm, to any former, current, or prospective student .... The term "hazing" does not include customary athletic events or school sanction events. Neither the express or implied consent of a victim of hazing, nor the lack of active participation in a particular hazing incident is a defense. Apathy or acquiescence in the presence of hazing is not a neutral act, and is also a violation of this section.





## What is Cost of Attendance (COA)?

The Cost of Attendance is an ESTIMATE of your educational expenses for a given period of enrollment.

- It consists of both Direct Costs, those paid directly to CSUN, and Indirect Costs, those which might not be paid directly to CSUN.
- Direct Costs may include tuition and fees, and on-campus room and board.



# How Can Students Limit The Cost?

- Finish in four!
  - Attend full time; 15 units per semester
- Take only required coursework for degree
- Think twice before changing major or adding minor
- Avoid repeating classes
- Live with more roommates if living off campus
- Live at home if possible
- Rent or buy used books and course materials

### **Expected Family Contribution (EFC)**

#### What does this number mean?

- Comes from the FAFSA/CADAA application
  - Collects demographic and financial information
  - Information used to calculate the expected family contribution (EFC)
  - Based on a federal formula
- Stays the same regardless of college
- Colleges use EFC to award financial aid and to determine eligibility
- Not a price, charge, or payment





## ADDITIONAL RESOURCES

#### **FamilyPACT**

The SHC is a FamilyPACT provider. FamilyPACT is a California program that provides free sexual and reproductive health services to eligible low-income individuals. Students can contact us for information on how to apply.



#### After-hours Care - Fonemed

After-hours nursing telephone service. Fonemed staff can answer medical questions, provide information on self-care, and help direct students to urgent/emergency care, if needed. Please note that any costs urgent/emergency care incurred are the student's responsibility.



#### Vaccine Assistance Programs

The Vaccines For Children (VFC) program is a federally funded program that provides vaccines at no cost for those who meet eligibility requirements and are under 19 years of age. Students can call the health center regarding eligibility.



## IMMUNIZATION REQUIREMENTS

All incoming students are required to comply with the California State University (CSU) systemwide updated EO 803 Policy on Immunization Requirements and Recommendations. Students must provide immunization records or proof of immunity to the following:



**Hepatitis B:** Required for students 18 years of age and younger at the time of the first day of attendance.

Additionally, California State University Northridge requires that students provide the same records or proof of immunity for:



Measles, Mumps and Rubella (MMR): Two doses are required, with the first dose on or after first birthday.





## IMMUNIZATION REQUIREMENTS

## How to satisfy the requirement

Submit Official Immunization Records

Students can upload records to the Klotz Student Health Center MyHealth patient portal. Records will be processed within five business days.

Obtain a Titer Test

A titer test can be used when immunization records are unavailable. A titer test is a laboratory test used to determine immunity to an infection/disease. Students can schedule an appointment for a titer test at the Klotz Student Health Center or with their healthcare provider. Titer test records are official immunization records.

Submit an Exemption Request

A student may be exempted from these requirements with a verified medical or religious exemption.

## IMMUNIZATION RECOMMENDATIONS

The CSU strongly encourages students to obtain the following immunizations and screening. Please discuss these immunizations with your healthcare provider. Information on these immunizations is available on the California Department of Public Health webpage for California colleges.

#### **Recommended Immunizations**

- Influenza vaccine
- Meningococcal Conjugate (Serogroups A, C, Y, W-135) Vaccine
- Serogroup B Meningococcal Vaccine
- Tetanus-Diphtheria-Pertussis (Tdap) Vaccine
- Varicella (Chickenpox) Vaccine
- Hepatitis A (Hep A) Vaccine
- Hepatitis B (Hep B) Vaccine Ages 19 and older
- Human Papillomavirus (HPV) Vaccine
- Pneumococcal Vaccine
- Polio Vaccine

#### **Recommended Screenings**

Tuberculosis screen/risk assessment





## **FAQS**

#### Do you take insurance?

Health insurance is not required to use the health center. If a service has a cost, such as
medication or lab work, we may be able to bill a student's insurance. We can also provide a
receipt that can be submitted to an insurance company. Please note that any costs not
covered by the insurance company are the student's responsibility.

#### If a student uses a service that has a fee, how do they pay for it?

• All fees are applied to their CSUN financial account. They will pay for these services the same way they pay for registration and other fees.

#### Do you only see students?

• The majority of our services are only available to enrolled CSUN students. We do have some services available to staff/faculty.

#### Can students request their medical records to take to their own medical provider?

• Yes, all records can be requested to take to their medical provider (release of information). And students can also bring in personal medical records to add to their campus records.





## **Student Challenges**


- Academic workload
  - Different expectations than high school
- Adulting responsibilities!!!
- Social interaction
- Physical wellbeing
- Emotional wellbeing
- Time management /Finding balance between all of these





## **Supportive Listening**

- Try your best to listen without judging or pressuring
- Try to avoid distractions
  - Private space
  - No phones, texting, multi-tasking, etc.
- If in-person or video, check your body language
  - Uncross arms, eye contact, nodding, etc.
- Manage your own anxiety
  - Leaning into patience
  - → Mistakes will be made and that is ok



## **Supportive Communication**


- Use encouragers ("uh-huh", "sure", "yeah")
- Ask open-ended questions
- Express appreciation that they're being open with and trusting you, it will encourage more of it
- If you have concerns, be direct about observations of changes
- Try to not overuse potentially minimizing statements ("Don't worry about it", "You'll be fine")

The best thing you can do for your student is to get them to ask for help.
