The Business Honors Program is designed to provide a stimulating learning environment for undergraduate business and economics students who uphold the highest academic and personal standards and aspire to become ethical leaders. The Program is open to students who are declared majors in Accountancy, Economics, Finance, Information Systems, Management, Marketing, or Business Administration with an option in Business Law, Global Supply Chain Management, Real Estate or Systems and Operations Management.

ADMISSION REQUIREMENTS

For admission to the Honors Program, students must meet the following minimum requirements:

- **First-time Freshman Applicants** must meet one of the following qualifications:
 1. GPA: A cumulative high school GPA of 3.7, OR
 2. SAT: Combined Math, Verbal, and Writing score of 1950 (or equivalent combined ACT score)
- **College Student Applicants:** Minimum college GPA of 3.5
- **Submit a completed application and one (1) recommendation**
- **Be interviewed by the Business Honors Program Director**

THE BUSINESS HONORS PROGRAM OPERATES ON A ROLLING ADMISSIONS CYCLE

ACADEMIC REQUIREMENTS (18 UNITS)

(1) Business Honors Designated Courses Requirement: 9 or 12 units

Each student must successfully complete 9-12 units of designated Business Honors courses. These courses may be elective or core classes. The following upper-division core and elective classes are usually offered annually:

PARTICIPATION REQUIREMENTS
