# REQUIRED BUSINESS CORE COURSES

A Business Major is any student majoring in Accountancy, Information Systems; or Business Administration with an option in one of the following: Business Analytics, Business Law, Financial Analysis, Financial Planning, Global Supply Chain Management, Management, Marketing, Real Estate, Risk Management and Insurance or Systems and Operations Management.

All business programs are accredited by AACSB and therefore have the same core requirements. Students will be held to fulfilling all prerequisite courses. The prerequisites for Business courses are listed below and also available in the current CSUN Catalog.

<b>ECON 161</b>	<b>Principles of Macroeconomics (3)</b> <i>Prerequisite: 1) GE-level Mathematics and (2) GE-level Written Communication or completion of 113A or 114A. ECON 160</i>
<b>IS 212</b>	<b>Info Systems for Business Users (3)</b>
<b>SOM 120</b>	<b>Basic Business Statistics (3)</b> <i>Prerequisite: Grade of "C" or higher in MATH 103 or higher-level mathematics course</i> <b>NOTE:</b> The 4-unit MATH 140 course also satisfies this requirement
<b>ENGL 205</b>	<b>Business Communication (3)</b> <i>Prerequisite: Completion of lower division writing requirement: GE (A2); Recommended Preparatory: GE (A1); IS 212</i>
<b>BLAW 280</b>	<b>Business Law I (3)</b> <i>Prerequisite: Completion of lower division writing requirement: GE (A2) and sophomore standing</i>
<b>MATH 103</b>	<b>Mathematical Methods for Bus (3)</b> <i>Prerequisite: Eligibility for GE Level Mathematics</i> <b>NOTE:</b> MATH 103 or higher-level mathematics course must be completed with a "C" or higher

## UPPER DIVISION CORE REQUIREMENTS (19 UNITS)

<b>BUS 302L</b>	<b>Gateway Lab (1)</b> <i>Prerequisite: Junior standing, Lower Division Business Core: ACCT 220, ACCT 230, ECON 160, ECON 161, IS 212, SOM 120 or MATH 140, ENGL 205, BLAW 280, and MATH 103.</i>
<b>FIN 303</b>	<b>Financial Management (3)</b> <i>Pre/Corequisite for Business Majors: BUS 312 + BUS 302L</i>
<b>MGT 360</b>	<b>Management and Org. Behavior (3)</b> <i>Pre/Corequisite for Business Majors: BUS 312+BUS 302L</i>
<b>MKT 304</b>	<b>Marketing Management (3)</b> <i>Pre/Corequisite for Business Majors: BUS 312 + BUS 302L</i>
<b>SOM 306</b>	<b>Operations Management (3)</b> <i>Pre/Corequisite for Business Majors: BUS 312+BUS 302L</i>
<b>BUS 497</b>	<b>Capstone: Strategic Management (3)</b> <i>Prerequisite: BUS 312+302L, FIN 303, MGT 360, MKT 304; Graduating senior standing (in final semester)</i>

**Transfer students** should be aware that no grade lower than a "C" will be accepted on transfer from another institution to satisfy department or David Nazarian College of Business and Economics requirements.

**NOTE:** BUS 302 no longer offered after Spring 2024. BUS 302 (if previously completed) will be honored in place of any BUS 312 prerequisite requirement
