<sup>6</sup> In lieu of filing a formal complaint, complainants may engage in early resolution where the complainant's concern may be resolved without a formal investigation. Examples of early resolution include, but are not limited to, implementation of a mutual no contact directive between the parties, a letter to the complainant's professors to indicate that the complainant may request reasonable classroom accommodations due to their experience, classroom adjustment, accommodations in Housing such as placing the respondent on the prohibited guest list in Housing, temporary emergency housing for the complainant, terminating housing lease, moving out, or transferring rooms without penalty.
