## **Anticipated Needs:**

University Counseling Services (UCS) is seeking to establish a part-time mental health counselor pool for the 2024-2025 academic year. Based on student demand for clinical services, part-time Staff Psychologists/Staff Counselors typically work up to 16 hours per week to supplement direct service hours at UCS.

## Responsibilities:

Will provide intake assessment, short-term individual and couples counseling, group therapy, crisis intervention, case management, and other duties assigned as needed.

#### **Qualifications:**

Master's or Doctoral degree in Counseling/Clinical/Community/Psychology or Social Work. Minimum of two years of experience that demonstrates the ability to work with students in need of mental health services. Demonstrated ability and commitment to working with a diverse student population. Preference will be given to candidates who have university/college counseling center experience and are licensed as a Psychologist, Social Worker or Marriage and Family Therapist at time of employment.
