The committee reviewed the proposed changes to the Policy on Credit Certificates to create an additional type of certificate that would allow 300-level courses. There has been a significant demand for post-baccalaureate students to increase their knowledge and professional skills in specialized fields such as pre-med and pre-law opportunities for CSUN students in addition to the registered dietitian nutritionist prerequisite coursework discussed at the last meeting. After some discussion, the committee decided that the new certificate type would be called the Post-Baccalaureate Certificate, and it was **MSP approved** to add it to the existing policy.
