Camara, Director of the Office of Academic Assessment and Program Review discussed the new assessment model iROCA (Instructors Reporting on Classroom Assessment) and shared that the full implementation of the new process starts in Fall 2023. She explained that the <a href="video">video</a> for the Fall 2023 ILO assessment rollout is to help faculty understand the assessment process and to know what they would be expected to do during the process. Camara also stated that her office would like to partner with Graduate Studies to offer workshops to help departments understand the Graduate ILOs.

D. Spratt shared the proposed change to the Leave of Absence for Graduate Students. The committee agreed with the proposed change but asked if graduate students need to be in good standing to take a leave of absence. L. Kiapos stated that students do not need to be in good standing to take a leave of absence, so it was decided to also remove "in good standing" from the document. The changes to the Leave of Absence for Graduate Students were **MSP approved**.
