This is to advise of the review, revision, and reissuance of department policies and procedural directives of the CSUN Department of Police Services (DPS). Over the past few months the command staff and I have made progress in moving this process forward; yet it will remain on-going in the coming year as we move forward with the re-organization process recently placed into effect. Attached are two spreadsheets itemizing the following:

1. Those policies and procedural directives reviewed, updated, approved, and enacted under my administration (Alfredo B. Fernandez, Chief of Police).
2. Policies and procedural directives issued under the previous DPS administrations of which I am approving to remain in effect under my administration, until such time they are reviewed, updated, and issued under my authority.

At the present time, no changes to department employee work expectations have been made. Only formatting, structure, spelling, punctuation, position titles, and command staff job responsibilities have been updated in the policies and procedures re-issued/issued under my administration. Policy 23-S.O.-025 *Naloxone* is a new policy that will take effect April 28, 2023.

As per Senate Bill 978, all police department policies and procedures must be placed on line for public viewing effective January 1, 2020.
