## BENEFITS ELIGIBILITY – Fall 2017

### IMPORTANT NOTICE

*ELIGIBLE EMPLOYEES HAVE 60 DAYS FROM THEIR DATE OF APPOINTMENT (August 23, 2017) TO ELECT AND ENROLL IN A MEDICAL, DENTAL, VISION, FLEXCASH and FLEXIBLE SPENDING ACCOUNT*

**\*NOTE:** FlexCash is an optional benefit plan that allows an otherwise benefit-eligible individual to waive medical and/or dental insurance coverage in exchange for cash, provided the individual has other **non-CSU coverage**.

#### Fall Appointment:

- Effective date of Medical, Dental and Vision coverage is October 1, 2017. You must enroll by Friday, September 8, 2017.
- Effective date of FlexCash is November 1, 2017. You must enroll by Friday, September 8, 2017.

Less than 6.0 units and a semester appointment

**OR**

**All other Unit 3 Faculty:**  
If you do not fall into any other appointment categories

7.5 units or more and an academic year appointment  
7.5 units or more and an appointment of at least 6 mos & 1 day  
*(12-month classifications)*
