## SENATE EXECUTIVE COMMITTEE MEETING MINUTES

Faculty President Neubauer called the meeting to order at 1:02 p.m.

Faculty President Neubauer welcomed the new Faculty Senate Office Manager, Deborah Kusin, joined by the Senate Executive Committee Members.

### 4. Provost's Report -Provost Mary-Beth Walker

Provost Walker reported on the following:

- a. Enrollment trends, trajectory, and strategy:
  - a. CSU wide undergraduate enrollment (head count) is down by about 10,000, with variations among campuses. Graduate enrollment (head count) is up by 2,000.
  - b. Nationwide, community college enrollment decreased by 3% last year and another 3% this year, suggesting a changing enrollment trajectory combined with demographic and other environmental issues surrounding enrollment in four-year universities.
  - c. The Enrollment Management Council, including Faculty President Neubauer, some Department Chairs, and Deans, will be the consulting body on enrollment. Invite to the Faculty Senate Meeting in Spring 2022.

- d. While CSUN's application deadline is on December 15, some CSUN campuses pushed it to January and February.
- b. Campus Road Map update:
  - a. Want to have the Road Map to be on agenda for the next SEC meeting.
  - b. The role of the steering committee is to facilitate campus engagement and capture and reflect our collective efforts to co-create the future with shared values and mission.
