3. President's Report – Michael Neubauer

Faculty President Neubauer shared information on the Statewide Senate Chairs meeting, the Faculty Trustee process, Assembly Bill 928 and the new CSUN conference center.

4. Provost's Report – Provost Mary Beth Walker

Provost Walker briefly reported on the following:

- a. Provost Walker shared an update on the Tactical Repopulation Group, LA County guidance and the campus repopulation plan. Data from student surveys show that students want in-person and virtual class options.
- b. Staff are being invited to meetings about the gradual repopulation plan. After July 4th, repopulation of staff offices will be at about 25%. The plan is 50% repopulation by the Fall.
- c. For the budget, continuing money is in place for about 24 faculty hires.
- d. The multi-factor authentication process timeline might be moved forward for security purposes.
