# **FACULTY SENATE MEETING Minutes of Meeting of May 5, 2022**

### 1. President's Report– Erika D. Beck

President Beck sends her best wishes to the Faculty Senators on this final Faculty Senate meeting of the academic year. She thanks the Senators for their continued dedication and commitment to our students this past year as we navigated shifting modalities and the evolving expectations of our students and each other. She is confident that our next academic year will allow even more opportunities to come together as a community to enable our students to achieve their highest aspirations.

### COVID and Semester & Beyond

Forward progress continues in our collective COVID response. While overall case counts remain relatively low, we have seen a slight uptick in both student and employee cases over the last couple of weeks. This reinforces the wisdom of our conservative approach with regard to maintaining masks in the classroom and work spaces as we enter finals and approach commencement. The mask policy will be revisited after commencement.

Additionally, we are continuing to fund the work of a COVID operations team dedicated to contact tracing, case notifications, and data tracking as we approach the end of the semester. This

keeps us in a solid state of readiness in the event we experience any significant changes in the trajectory of the pandemic.

Fall semester is being planned as almost back to pre-COVID status, incorporating all that we have learned over the last two years and applying those lessons for the good of the campus community. For instance, there will be a few more virtual and hy-flex offerings than were offered prior to COVID.

As always, the health and safety of our entire community is our top priority, and we will continue to follow public health guidelines and any local mandates that may occur. President Beck thanks everyone for their efforts to keep the campus community safe, informed, and moving forward.

President Beck was pleased to speak at events that celebrate our campus values, including CSUN's first Digital Equity Day, hosted by Information Technology, which focused on how technology can be instrumental in facilitating equity and inclusion on campus and virtually. She was also privileged to welcome Ibram X. Kendi who spoke on Becoming an Anti-racist Advocate. This was part three of the Examining Our Campus series: Essential Talks, Anti-Racist Learning Network.

President Beck met with the new president and new provost of the American University of Armenia, a CSUN international student exchange partner to discuss additional opportunities for collaboration; she toured JPL with Professor Nhut Ho; and she and Dean Toutanji met with the CA Department of Industrial Relations to learn more about the LA Cybersecurity Consortium for apprenticeships and career pathways for cybersecurity students.

President Beck was pleased to be invited to participate in a panel discussion with California Community College Chancellor Eloy Ortiz Oakley on the state of higher education at a Lumina Foundation event. She also enjoyed presenting to the Los Angeles County Business Federation (BizFed) Board of Directors, a large business and trade association representing every industry in and around Los Angeles.

President Beck also had the opportunity to meet individually with Assemblymember Suzette Valladares and Councilmember John Lee and with the Hollywood Foreign Press Association to explore additional opportunities to support our students.
