**Current Courses or Specialization**

English 113 (two semester sequence of first year "Stretch" composition for Deaf and Hard of Hearing Students with Supplemental Instruction Leaders), English 114 (two semester sequence of first year "Stretch" composition for Deaf and Hard of Hearing Students), and English 115 (one semester of first year composition for Deaf and Hard of Hearing Students).

**Qualifications**

Master's or Doctoral degree in English or English-related field or Special Education where emphasis has been on instructing deaf and hard of hearing students in reading, writing, and critical thinking.

Experience teaching at least two semesters of 3-credit writing courses at the college level.

Documented effectiveness in teaching English, and particularly critical reading and writing, to deaf and hard of hearing students at secondary institutions and/or at the college level.

Fluency in English and in American Sign Language.

Ability to use both English and ASL in instruction.

Coursework in teaching strategies, methodologies, and assessment of student learning, especially as it pertains to students who are deaf and hard of hearing and for whom deafness may be only one of multiple conditions affecting learning

Completion of training in Stretch composition workshop required prior to the start of assignment.

Potential English 113 faculty must demonstrate commitment to and interest in mentoring and working with Supplemental Instruction Leaders.

Demonstrable commitment to working with a diverse student population.

Evidence of certification in online teaching (QLT, ACUE, etc.) is required for assignment to online courses.

**Salary Range**

Base Rate: \$4229-\$5046 per 3-unit class, commensurate with terminal degree and prior experience. From \$704.83 to \$841 per course per month, for a 6-month pay period.

2. Cover letter which designates specific courses applicant is interested in teaching.
3. Two-page statement of philosophy for teaching first year college composition.
4. Proof of degree (i.e. photocopy of diploma or transcripts).
5. Two letters of recommendation that, preferably, speak to teaching excellence at the college level.

The C.V. should include educational background, prior teaching experience at the college level, evidence of scholarship, and/or related professional experience. These documents must be submitted to the address in the section below. In later phases of the search process, applicants may be requested to provide verification of terminal degrees, licenses and certificates.
