Sponsorship of the CSUN Center for Risk and Insurance benefits Farmers in numerous ways. In addition to being aligned with Farmers' brand campaign, actively supporting insurance education at the university level furthers the Company's community relations efforts. Additionally, direct interaction with today's undergraduate students - many of whom are tomorrow's business leaders - provides a perfect opportunity to profile insurance as a career of choice, and Farmers as an employer of choice.

Using the text and course guide for the CPCU 520 exam ("Insurance Operations") as a backbone, the Farmers course surveyed all aspects of property casualty insurance company operations. Class session topics spanned the gamut from property claims to loss control, and from regulatory affairs to strategic planning, and finance. What was really unique about the course, however, was that the various class sessions were taught by different Farmers employees - each a subject matter expert in the area being taught. "It was great to have a hand in developing and sharing my experience with these students," said Jeff Reinig. "Not only were we able to expose them to the value of CPCU curriculum, but we able to show them how it applied in the real world and how they could be successful in the insurance industry.

Identifying potential speakers from the Farmers ranks was, perhaps, the simplest part of the whole effort. As Bill Riedley puts it: "I was particularly impressed with how easy it was to find engaged and knowledgeable employees willing to give up their time to teach the next generation of business leaders, and to be part of Farmers' efforts to give back to the local community."

Although most presenters worked alone, we had several successful "tag teams" leading class sessions. One of the most memorable teaching duos included Shawn Carder, CPCU and Patrick Carder, who presented a session on "Adjusting Property Insurance Claims". This father and son team, both Farmers Claims professionals, did a great job representing the Company, and in conveying their material. Patrick, a recent college graduate himself, was able to establish a real connection with the students by bringing in "props" from some of his claims, and by highlighting the cutting edge technology he uses in his work. On collaborating with his dad, Patrick says: "...having a professional like my dad involved in the class is the greatest advantage that Farmers has in opportunities like this. Thank you again for this experience. Farmers really nailed this one."

Another highlight of the course involved a "field trip" to the University of Farmers. On October 21, 2013, approximately 40 CSUN Insurance Studies students (from both our class and the lower division Insurance Survey course) were treated to a tour of the facility, and learned firsthand why the U of F receives such high praise, year after year. Dr. Russell summed up the experience as follows: "All I can say is WOW! Thank you so much for hosting such a large group of our students. All of the students left the building with smiles. And several told me that a career in Insurance was no longer far-fetched. Just like the Farmers volunteers in Joplin, it says a lot about Farmers that you share your time and resources with our students in this way. I think Insurance as a career, and Farmers in particular, had a very good day, indeed."
