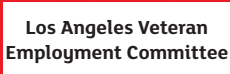

# About the Initiative

The CSUN VITA Clinic is launching an innovative partnership to provide outstanding free tax preparation services and training in taxation to Los Angeles County's veteran population. Offered at multiple locations throughout Los Angeles County, the free services will empower veterans to serve their fellow veterans as IRS Tax Law Certified Volunteers throughout the 2019 tax season.

## About Your Role

The CSUN VITA Clinic is looking to recruit, train and supervise up to 50 veterans who would like to serve as volunteer tax preparers in one of the clinic's sites during the 2019 tax season. Each Veteran Tax Fellow will be provided with free access to the CSUN VITA Clinic's educational training (approximately 32 hours of on-line and in-class training to take place in January) to become an IRS Tax Law Certified Volunteer. Once certified, the Veteran Tax Fellow will be deployed in one of 20 sites throughout Los Angeles to serve low-income veterans with free tax preparation (at least 12 hours of service).
