About the University:

M.F.A. required in Film and/or Television Production. Professional experience in cinematography in film or television is required. Significant relevant industry experience and/or scholarly publication may be considered in lieu of advanced degree.

Editing

College-level teaching experience is highly desirable. M.F.A. required in Film and/or Television Production. Professional experience in television or documentary editing is required. Significant relevant industry experience and/or scholarly publication may be considered in lieu of advanced degree.

Sound Production

Professional experience as a director in scripted or un-scripted production is required. Significant relevant industry experience and/or scholarly publication may be considered in lieu of advanced degree.

Episodic Half-Hour/One-Hour Production

College-level teaching experience in half-hour/one-hour episodic television production is highly desirable. M.F.A. required in relevant field. Professional experience as a producer or a director is required. Significant industry experience and/or scholarly publication may be considered in lieu of advanced degree.

Directing the Documentary

College-level teaching experience in documentary production is highly desirable. M.F.A. required in relevant field. Professional experience as a producer or a director of un-scripted content is required. Significant industry experience and/or scholarly publication may be considered in lieu of advanced degree.

Production Management

College-level teaching experience in production management is highly desirable. M.F.A. is desired. Professional experience as a production manager or an assistant director is required. Knowledge of movie magic software is required. Significant industry experience and/or scholarly publication may be considered in lieu of advanced degree.

The resume should include educational background, prior teaching experience, evidence of scholarship, and/or related professional experience.
