**Qualifications:** The Department of Communication Studies at CSUN/Civil Discourse & Social Change (CDSC) seeks a qualified candidate to fulfill a graduate assistant position. The candidate must have the following qualifications: currently enrolled as a full time or part time student in a M.A. program at CSUN; demonstrated excellence in writing; exceptional organizational and interpersonal skills, ability to work with Canvas and Zoom, and interest in social justice.

**Responsibilities:** The main responsibility of the graduate assistant is to provide support for faculty member, Reverend James Lawson, Jr. for the course, *Nonviolent Struggle, Civil Rights, and Social Change*. The graduate assistant is expected to attend all class sessions during spring semester 2023 (Tuesday, 4:00-6:45pm), interface with Rev Lawson, maintain the course Canvas page, and assist with exam preparation and grading.

**Application Deadline:** Applicant review will begin 1/10/23 and will remain open until the position is filled.

<u>Please note</u>: Students applying for Graduate Assistant positions must be currently enrolled in a graduate program. Graduate Assistants provide non-teaching assistance to faculty members and gain practical experience in fields related to their advance study. Academic Student Employees may not concurrently hold a faculty or staff position. Students with assignments in more than one student classification (i.e. Teaching Associate and Graduate Assistant) are restricted to working a maximum of 20 hours per week during the Academic Year. The 20 hour per week maximum includes hours worked in all positions.
