The Department of Educational Leadership and Policy Studies seeks a Graduate Assistant to work directly with department faculty to provide research support as needed. We need a self-motivated, hardworking graduate student. This position works directly with two graduate faculty members, yet also independently on activities as assigned. It offers a flexible schedule and requires a commitment of 10 hours per week.

Qualifications: Must be enrolled in a CSUN graduate degree program and have excellent organizational skills, analytical skills and computer skills: MS Word and MS Excel; Comfort and familiarity with statistical software SPSS.

Responsibilities: Providing research assistance to faculty conducting authorized research; collecting and arranging data, developing source materials, summarizing reports, preparing and caring for research materials.

Please note: Students applying for Graduate Assistant positions must be currently enrolled in a graduate program. Graduate Assistants provide non-teaching assistance to faculty members and gain practical experience in fields related to their advance study. Academic Student Employees may not concurrently hold a faculty or staff position. Students with assignments in more than one student classification (i.e. Teaching Associate and Graduate Assistant) are restricted to working a maximum of 20 hours per week during the Academic Year. The 20 hour per week maximum includes hours worked in all positions.
