Qualifications: Current Geography Major or Minor preferred in good standing. Grade point average of 3.0 or higher. Must have completed coursework in the relevant regional geography course. Must be responsible, conscientious, well organized and possess excellent oral and written communication skills. Must be willing to review assignments before meeting with the student(s). Able to work with faculty members and students of the class/lab. Able to use applicable technology and software (i.e., computer, CSUN portal, email and Microsoft Office 365 Suite).

Responsibilities: Serve as an Online Grader for regional geography of the United States (GEOG 321) and/or Latin America (GEOG 322). Under appropriate supervision by the course-assigned faculty member, you will be expected to demonstrate specific advanced knowledge of the course content by implementing the faculty members course content and methodology. This knowledge will further be used to assess student work and provide the authority to assign a grade within a range of points established by the Professor/Instructor.

Please note: Students applying for Instructional Student Assistant positions must be admitted or registered as a CSU student. Under supervision, Instructional Student Assistants in this classification perform teaching, grading or tutoring duties for the majority of work hours in a given appointment in a given academic department or equivalent administrative unit over the course of an academic term. The work may be performed on-campus or at an off-campus public agency or private non-profit organization under an agreement with a campus in the CSU system. Academic Student Employees may not concurrently hold a faculty or staff position. Students with assignments in more than one student classification (i.e. Teaching Associate and Graduate Assistant) are restricted to working a maximum of 20 hours per week during the Academic Year and up to full-time during academic break periods. The 20 hour per week maximum includes hours worked in all positions.
