 - ii. Compose through recursive stages of drafting, feedback, and revision.
 - iii. Apply a variety of teaching and practices to all stages of the writing process (invention, drafting, researching, writing, revising).
 - iv. Use information technologies to support tasks.
 - v. Ethically integrate sources into their writing, using common citation practices (MLA, APA, etc.).
 - vi. Develop well-organized and well supported documents that effectively communicate their own ideas.
 - vii. Locate, research, and contemplate a topic with which they can engage through a variety of writing genres.
