


SPRING 2024 SEMESTER IS UNDERWAY


IESC WEEKLY COFFEE HOUR

Here are some general reminders provided by our SEVIS Coordinators regarding your SEVIS immigration record/ Form I-20. This information will assist us in helping you maintain your immigration status.

- Foreign (F) Hold will be placed on your CSUN Student Portal at the beginning of each
 registration period per semester. The foreign hold will prevent you from registering in
 courses. Once we receive proof of health insurance, we can remove your foreign (F) hold for
 the semester. To purchase health insurance please visit the health insurance requirement
 page.
- Must remain enrolled in full-time course load for Spring 2024 (undergraduates with a minimum of 12 units and graduates with a
 minimum of 8 units). Make sure to contact your ACADEMIC ADVISOR to plan for future semesters including the upcoming fall
 2024 semester. Please remember that all F1 students are permitted to enroll in no more than the equivalent of one online class
 or three online credits per semester to count towards your full-time enrollment. Please register for classes accordingly. If
 your schedule has changed, please contact your <u>International Student Advisor</u> immediately.
- Is your CSUN I-20 expiring soon? If you will NOT COMPLETE your degree at the end of Spring 2024 semester (05/24/2024), you
 must apply for an Extension of Stay in order to continue your studies and to remain in correct status with immigration for
 future semesters. IESC will need to receive the documents listed below via email: iescrequest@csun.edu
 - Completed <u>Extension of Stay Request Form</u> Your Academic Advisor will need to assist you by completing page 2 and submitting it to <u>iescrequest@csun.edu</u> (see instructions on the form for more information).
 - Copy of <u>Affidavit of Financial Support</u> (include dependents if applicable).
 - o Copy of Bank Statement for the amount on the Affidavit of Financial Support.
- Maintain a valid U.S. address at all times and update your CSUN Student Portal account. The U.S. address is required to keep your SEVIS immigration record in good standing. Any changes must be reported within 10 days of the change. <u>Learn how to keep your</u> information updated.
- Are you planning to travel during spring or summer break? Be sure to check on your CSUN I-20 on page 2 to make sure that you
 have a valid travel signature. The travel signature is valid for 12 months from the date we signed as long as you are maintaining
 your F-1 status, and your passport and visa are valid.
- If you are graduating from CSUN this Spring 2024 semester and are interested in applying for Optional Practical Training (OPT),
 please visit the IESC Events and Webinars to join a QEA POST-Completion Optional Practical Training webinar and to prepare for
 POST OPT application process.
- Are you currently on OPT status? Do not forget to report your required <u>POST- OPT</u> or your <u>STEM OPT</u> information in a timely manner.



NOW OPEN: National Student Exchange DIRECT PLACEMENTS

There are 150+ NSE campuses accepting students for the 2024-25 school year! See list of available campuses (and deadlines). Here are some descriptions you need as you go through the list of campuses:

OPEN = host campus will accept all eligible applicants before their stated deadline

LIMITED = space is limited...home coordinator should contact host coordinator before submitting placement

WAITLIST = home coordinator should contact host coordinator and ask to put student on the waitlist before submitting **placement**
