FACULTY SENATE MEETING – Approved Minutes of Meeting of April 7, 2022 Via Zoom

Faculty President Neubauer called the meeting to order at 2:00 p.m.

5. Discussion Item: AB-928

Dan Weingarten, Chair, Educational Policy Committee; Elizabeth Adams, AVP, Undergraduate Studies; Rob Collins, Chair, Statewide Academic Senate California State University

EPC Chair Dan Weingarten presented AB 928 overview, followed by the ASCSU Chair Rob Collins answering Senators' questions and addressing comments. Discussion focused around the question, 'Why AB 928?' The Assembly Bill's purpose is to enable a smooth transfer into a CSU. Senators shared concerns, including the magnitudes of existing oral communication General Education courses and their significance for our students, and possible subsequent unit increase in some majors.
