FACULTY SENATE MEETING MINUTES – Approved **December 9, 2021 Meeting**

Faculty President Neubauer called the meeting to order at 2:00 p.m.

The Secretary called the roll. Senators not present were Jeff Campbell, Marquita Gammage, Tomo Hattori, Julian Lozos (excused), Theresa Montaño (excused), Mary-Pat Stein (excused), and Francisco Tamayo

The Faculty Senate Minutes for November 18, 2021, was approved.

1. Introductions – Theresa White, Vice President of Faculty, and Katherine Stevenson, Senator

Six (6) Senators as part of the Senator introductory series were introduced to the Senate: Lindsay Henson Brown, University Library and Chair, Personnel Planning and Review Committee; Krystal Howard, Liberal Studies; Matthew Jackson, Theater; Kim Henige, Kinesiology; Jinah Kim, Communication Studies; Wayne Smith, Management

2. Announcements – Judith Debonis, Chair, Faculty Retreat Committee

Professor DeBonis shared the theme of the Faculty Retreat "Journeys & Connections," retreat location -Orchard Conference Center, and number of registered attendees.

3. CSU California Desert Consortium – Terry McGlynn, Director, California Desert Studies Consortium, Biology, CSU Dominguez Hills

CSUN is a Consortium member. The facility at Zzyyx Road is available for research groups. The campus has accommodations for students during their research projects.

4. Faculty Technology – Ranjit Philip, VP Information Technology, Helen Heinrich, AVP Academic Technology

Introduced a new series of workshops for faculty on the Academic Tech webpage for faculty to access. One new series is workshops such as Ask an Expert – every Monday at 11:00 am.

5. Basic Needs Initiative – William Watkins, VP Student Affairs and Dean of Students; Nelida Duran, Family and Consumer Sciences; Deborah Hammod Executive Director, University Student Union; Shelley Ruelas-Bischoff, Associate Vice President for Student Life

Dr. Duran shared research findings on CSU student basic needs. Centrally located partnerships are to provide student engagement opportunities and resources for basic needs for students experiencing homelessness and food insecurity, among others.

6. President's Report – Erica Beck

7. Associated Students Report – Jonathan Hay, AS President

AS President Hay shared issues students expressed: 1) students are not aware of resources on campus, 2) advisement hours are not posted, 3) advisors have small windows for counseling sessions, 4) permission numbers for class enrollment roll out slowly, and 5) if a student is not feeling well and reaches out to their professor to let them know, the students feel like they will be punished. On 12/10/21 students will have a campus conversation with Provost Walker.

8. Provost Report – Mary-Beth Walker

In response to the AS President Hay, Dr. Watkins and Provost Walker have been working to make improvements across the university such as the number of advisors and transfer students coming to the university. Further, the next generation Degree Progress Reports will be more dynamic to let students take initiative.

Provost Walker spoke on the update on searches for the Chief Information Officer (CIO), Vice President Information Technology, was underway. The search for the Dean of College of Humanities resumed, and the search for the Dean of College of Health and Human Development just began.
